Police Department

Police & Code Enforcement August Reports

Council member Munoz commented saying she had no questions, but she said that is a lot of calls, she isn't sure if anything changed because we are fully staffed now. Lieutenant Marks responded that we have new officers, and they are getting more training and there is certain items they try to push on certain items, and we anticipate it will keep increasing. Mayor commented that this is a combination of police and code enforcement citations. We have had some concerns regarding the parking tickets on who is writing those tickets, Mayor wanted to make sure to let the community know that the code enforcement is writing those tickets not the police department. Lieutenant Marks mentioned that cars that are abandoned and have tabs expired over forty-five days on taxpayer roads can be towed at any time, but our code enforcement does give out grace periods and does provide some information on it when he marks the car with an orange sticker. Council member Bustamante asked if they could put out information to educate the community on that on the parking infraction. Mayor said two things one if anyone has a driver license you should know that parking against traffic is not legal that is on the exam to receive your driver license. But if anyone has any information there is contact information to contact the police department with any questions. Council member Stonemetz commented saying we have been reiterating information that has been educated with the city like special events, building permits etc. Mayor thanked them for their feedback.

BFET Work Based Learning Worksite Agreement

Mayor explained that Gloria Garcia reached out to Frank regarding a contact between People for People and the City of Granger for a duration of one month. All wages will be paid by people for people. The City will not be responsible for anything. If you have the chance to read the agreement it explains the terms and not holding the city harmless etc. Council member Munoz asked if they approached us, Mayor explained yes they talked to Frank about it. Mayor explained the public works is short staff at the moment so interim we will let this gentleman gain skill and help out the city, Can this be something that can be ongoing that the city does with people for people. Council member Munoz asked Frank if this was something that he had seen of a term of only a month and he said no he had seen agreements that were for three to six months. Mayor explained it is a case by case on how long the duration of the agreement is.

Expenditure Request-Lakeside Equipment

Frank explained that the aerators rotors are in need of bearings. We have them in the oxidation ditch at the sewer plant that breaks down all our organics. Frank went around and showed council members pictures and video of the bearings, and he explained they are completely gone and it's affecting other portions of the machine as well. Council member Stonemetz asked how old that system is, and Frank explained that he believes it was placed in 2014. Stonemetz asked what a whole setup cost instead of just purchasing only the bearings. Would it be better to do that instead of only bearings and have the rest of it break down years later. Frank said he will look into some numbers on the whole setup. Mayor asked so do we not approve the expenditure and wait for Frank to bring back a new expenditure for the whole setup. Frank commented we wouldn't be able to wait that long. Council member Stonemetz mentioned that no that is not what he means, mayor explained we would be paying the three thousand dollars anyways plus what's on top of that. Frank explained that the bearing should work. Council member Bustamante asks if there is multiple machines like this and Frank said four and those are good.
